Calendar Description

Drawing One is the introduction of core drawing practices at the entry level. This course provides an opportunity for students to develop their drawing skills, visual vocabulary, and understanding of conceptual and formal approaches to both historical and contemporary drawing.

Section II: Course Details

Detailed Description

Students explore the use of drawing to investigate contemporary approaches to the production of artwork. Students experiment with a variety of traditional and unconventional materials to investigate figurative drawing, observational drawing, conceptual drawing, and methods of rendering illusionistic space.

Through workshops, presentations, discussions, topical assignments and critiques, students develop a body of work that investigates the historical and contemporary practices of drawing. Students examine a variety of critical and thematic concerns of artists who draw, discourses surrounding their production, and the larger cultural implications of their work.

Program Context

The Art & Art History Program offers multi-level courses in six studio streams: drawing, painting, design, photography, print media and sculpture. Drawing 1 is one of six required, 0.5-credit studio courses that students are asked to take in their first two years of fulltime study. Students may elect to continue in the drawing stream by taking Drawing 2. After the first two years of study, students choose two studio streams to pursue at the year 3 and 4 levels. Drawing complements the other five studio streams in giving students the skills they need to make artwork that is visually coherent and conceptually and emotionally communicative.

Critical Performance

By the end of this course students will have demonstrated the ability to develop a body of work that investigates fundamental processes for creating representational drawings.

Learning Outcomes

To achieve the critical performance, students will have demonstrated the ability to:

1. Exhibit competence in using traditional and unconventional drawing materials and supports for creating contemporary drawings.
2. Exhibit competence in the fundamentals of gesture drawing, contour drawing, observational drawing, composition, texture, and value.
3. Exhibit competence in rendering illusionistic drawings of interior and exterior spaces.
4. Exhibit technical competence in foreshortening and rendering the figure.
5. Solve pictorial and conceptual problems through experimentation, revision and resolution.
6. Write a Visiting Artist review.
7. Establish the relationship between form, technique, and concept through the development of artwork and by engaging in peer critiques to discuss their work.

- Through evidence of inventiveness and imagination
- Through intellectual approaches to problem-solving and appropriate resolution of work

Missed Term Work

Project Summery

Project #1: Absolute Garbage!

Grade Weight: 10%

Due: Sept. 24

This assignment works exclusively with tonal values to investigate how best to use contrast to develop an image. Both additive and subtractive strategies will be employed.

Project #2: Find a Line / Reality as Collaborator

Grade Weight: 10%

Critique: Oct. 1

Due: Oct. 8

This section of the course will investigate a variety of approaches to developing both descriptive line and invented mark-making techniques. Students will experiment with a variety of media. This assignment is intended as an opportunity for students to work with an ideas-based approach to their practice.

Project #3: Perspective

Grade Weight: 20%

Critique: Oct. 22

Due: Oct. 29

This section of the course will investigate a variety of approaches to rendering space, line, tone and texture. Students will experiment with both traditional and contemporary approaches to working with perspective and rendering interior spaces.

Project #4: Large Format Ink Drawing

Grade Weight: 25%

Part 1 Research Due: Nov. 25

Part 2 Final Drawing Due: Dec. 2

This section of the course will investigate how scale, line, and composition are developed in the creation of large format imagery. Students will experiment with both traditional and contemporary approaches to working with scale.

Project #5: Life Drawing Portfolio

Grade Weight 20%

Due: Dec. 3

This section of the course will investigate a variety of approaches to rendering the figure. Students will experiment with both traditional and contemporary approaches to working through compositions and poses.

Visiting Artist Review

Grade Weight: 5%

Due: Nov. 26

During the semester the AAH department invites visiting artists to come to the school and give a one hour presentation on their work. These lectures take place on some Tuesdays and Thursdays between 12:30 and 1:30. Students are required to attend one of these lectures and write up a review that outlines their personal opinions of the presentation and their impressions of the artist's work.
